##### **Reinforced Bone China**

Compliant to the requirements set out in Art. 3 of Commission Regulation (EU) No. 1935/2004 of 27. October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC, the material(s) used in these products are chosen for their technical quality as well as purity suitable for contact with foodstuffs.

The products listed above were manufactured of foodsafe bone china and are pursuant to the requirements outlined in European legislation regarding labelling and traceability.

EU Commission: In accordance with EU Commission Regulation no. 1935/2004 this product is intended for food contact. Therefore it can be marked with the "glass & fork" symbol either on the packaging or through labelling. Products are manufactured according to EU Commission Regulation no. 2023/2006 on good manufacturing practices for materials and articles intended to come into contact with food (GMP). Specific migration tests are made on similar products. Under Directive (EU) No. 84/500, relating to ceramic articles intended to come into contact with foodstuffs the above articles belong to Category 1, 2 and 3 as defined in Art. 2, (4) of (EU) No. 84/500. Specific migration of metals. In compliance with the requirements of Directive (EU) No. 84/500 the product samples were not found to release any excess of substances when subjected to a 4% acetic acid testing at  $22 \pm 2$  °C for a period of  $24 \pm 30$ min.
