### Specifications

#### **Foodsafe Melamine resin**

Compliant to the requirements set out in Art. 3 of Commission Regulation (EU) No. 1935/2004 of 27. October 2004 on materials and articles intended to come into contact with food and repealing Directives 80/590/EEC and 89/109/EEC, the material(s) used in these products are chosen for their technical quality as well as purity suitable for contact with foodstuffs. Current amended version with 2019/1381 (20 June 2019) is included.

The products listed above are manufactured pursuant to the requirements outlined in European legislation regarding labelling and traceability.

### EU Commission:

In accordance with EU Commission Regulation no. 1935/2004 this product is intended for food contact. Therefore it can be marked with the "glass & fork" symbol either on the packaging or through labelling.

Products are manufactured according to EU Commission Regulation no. 2023/2006 on good manufacturing practices for materials and articles intended to come into contact with food (GMP).

Overall migration tests are made on similar products. The products meet the requirements regarding overall migration testing to 10 % ethanol (food simulant A), 3 % acetic acid (B), 95% ethanol (D1) isooctane (D2). According to (EU) No. 10/2011, the materials with contact to food may not release more than 10mg/dm<sup>2</sup> of substance at any of 3 consecutive tests on a given sample. The tested samples comply with these requirements.

Specific migration of monomers. In compliance with the requirement of (EU) No. 10/2011 the sample was not found to release any excess of melamine or formaldehyde when tested 3 consecutive times with 3% acetic acid, for 2h at 70°C.

Specific migration of heavy metals. The products meet the requirements of Annex II, (1) of the (EU) No. 10/2011 regarding heavy metal migration under a 3% acetic acid testing, 3 consecutive times for 2 hours at 70 °C.

REACH 1907/2006. These products do not contain any traces of melamine CAS.nr 108-78-1, formaldehyde or any SVHC currently on the REACH Candidate List in detectable quantities.
